Introduction

The past year has been another successful year for the Land Division. Although the total acreage of land acquired has tapered off from the three previous years, staff in each of the four departments has been extremely busy as the economy rebounds and the nature of the workload continues to transition.

Included in this report is a summary of some of the accomplishments from the past year, activity measures that depict staff's everyday workload, and future challenges that each department faces as we look forward to the coming year.

Last year, the theme of the Land Session was an increased focus on obtaining and improving access to parks, and between parks. Establishing access and regional trail links is still a challenge and will continue to be for years to come. However, this year, each department recognized increased development activity as the primary challenge. Although the Division monitors and responds to the impacts that development has on District parklands in a unified voice, those impacts affect each department differently and result in a myriad of challenges—and potential opportunities.

In Land Acquisition, increased development activity causes land values to increase leading to a more competitive environment for purchases. The Interagency Planning Department studies changing demographics and contemplates the challenge of providing different recreational opportunities to meet the demands of our changing population. Environmental Programs envisions an increased demand for mitigation projects on our lands caused by increased development activity. The Resource Enhancement Program has been very successful in providing a mechanism for handling requests for mitigation on parklands, but it has clearly seen less activity in the past five years. Finally, the Trails Department recognizes that obtaining workable trail easements through and around new neighborhoods will continue to be a challenge as land becomes more scarce and valuable. However, these trails connections are vitally important in order to implement the vision of our Master Plan and connect our increasingly diverse communities.

As the District celebrates its 80th anniversary with the theme of *Connecting Parks to People*, the Land Division continues to work in a variety of ways to make physical connections, and ultimately emotional connections, between parks and people possible!

Land Acquisition

Since the last Land Session, the Land Acquisition Department has acquired an additional 1,020 acres at a cost of nearly \$8 million and been awarded over \$1.5 million in grants for their purchase. These new parklands will provide recreational opportunities for park visitors while preserving important viewsheds, wildlife corridors, and natural and cultural resources. The Department continues to take advantage of opportunities to leverage outside funding while also maintaining a geographic balance in the acquisition program. Key acquisitions since the last Land Session include the 90-acre Aginson Prime property at the future Delta Access Regional Recreation Area; the 31-acre Crader donation at the future North Richmond Regional Shoreline; the 362-acre FRB property on the east side of Wildcat Canyon Regional Park; the 165-acre APN property at Sobrante Ridge Regional Preserve; the 79-acre Eddie's Flat property at Brushy Peak Regional Preserve; and the 232-acre Castleridge property at Pleasanton Ridge Regional Park. In addition to closing escrow on these properties over the past 12 months, the Department also entered into option and purchase agreements in partnership with the East Contra Costa County Habitat Conservancy for two large ranch holdings scheduled to close escrow in July 2014, the 1,885-acre Roddy Ranch and the 960-acre Smith "Dainty" Ranch, both located at the site of the future Deer Valley Regional Park.

Land Acquisition continues to support other departments by acquiring the property rights necessary to implement the Capital Development and Regional Trails programs. Examples of these efforts include acquisition of right-of-way necessary to support the Atlas Road bridge construction, the Breuner Marsh restoration project, the Martinez Intermodal Center to Crockett segment of the San Francisco Bay Trail at Carquinez Strait Regional Shoreline, and the Tidewater Avenue entry widening at Martin Luther King, Jr. Regional Shoreline.

The Department's goal is to provide responsive customer service to other divisions and departments for various services such as land rights research; real estate document interpretation, encroachment resolution, as well as easement, lease, and license negotiation and procurement.

The Department will continue to seek opportunities to spend down remaining Measure AA funds and utilize Measure WW monies in accordance with the Master Plan and the Board's priorities, as well as leverage these funds with outside funding sources. Thanks to partners such as the East Contra Costa County Habitat Conservancy, the California Coastal Conservancy, the Wildlife Conservation Board, the Moore Foundation, the Alameda County Altamont Landfill and Resource Facility Open Space Advisory Committee, the Alameda County Surplus Property Authority, and the City of Livermore, we have been able to maximize opportunities to purchase strategic properties. We also have worked closely with local land trusts such as the Muir Heritage Land Trust, Save Mount Diablo and the Tri-Valley Conservancy on projects of mutual interest to preserve land and create trail corridors.

Activity Measures:

- Fielded 3 4 questions per day from the public and field staff, totaling responses to over 1,000 questions during the year.
- Evaluated multiple surplus property offers from other agencies, and reviewed 650 parcels on the Alameda and Contra Costa County tax deferred parcel lists for possible acquisition.
- Reviewed MLS listings on a monthly basis, resulting in several properties actively pursued for potential acquisition.

Future Challenges:

- 1) Depletion of Measure AA and WW monies in certain high-volume allocation areas (e.g. Black Diamond Mines Regional Preserve and Wildcat Canyon Regional Park).
- 2) Increased pressure to provide staging and public access into portions of the parks that have been landbanked for extended periods of time (e.g. Pleasanton Ridge Regional Park, Las Trampas Regional Wilderness and Vargas Plateau Regional Park).
- 3) Higher land acquisition costs due to economic recovery resulting in property values going up, together with increased competition for properties from the development community.
- 4) Depletion of acquisition funding sources, particularly at the State level (e.g. Coastal Conservancy) and "strings attached" with the funding sources that remain available (e.g. ECCCHCP).

Interagency Planning

Early staff involvement in local land use decisions, federal base closures, regional planning efforts and local general plan updates has positioned EBRPD well for future parks and trails while also protecting and expanding existing parks. These efforts often take many years to bear fruit as can be seen in the three examples below.

SB 375 Plan Bay Area: Plan Bay Area is a regional planning effort lead by the Metropolitan Transportation Commission (MTC) and the Association of Bay Area Governments (ABAG). The Department worked jointly with Government Relations/Legislative Affairs to seek meaningful financial incentives to protect vital natural resources in the Plan Bay Area project and sought significant mitigation measures to address impacts on District parklands. The District was successful in being awarded a total of approximately \$1.9 million in Priority Conservation Area (PCA) grants for three projects in the spring of 2014. The three projects were: 1) Breuner Marsh Restoration (\$1 million), 2) Pinole Shores to Bayfront Park Bay Trail (\$119,600), and 3) Gilman Street to Buchanan Street Bay Trail in McLaughlin Eastshore State Park (\$750,000). MTC and ABAG are beginning to prepare the next round of Plan Bay Area for adoption in 2017.

<u>Concord Naval Weapons Station (CNWS)</u>: Staff continues to work with the City of Concord, National Park Service (NPS), U.S. Navy and other key stakeholders to establish the proposed 2,500±-acre Concord Hills Regional Park. In May 2014, NPS formally requested the Navy to assign a 2,540-acre portion of CNWS to the NPS for public benefit conveyance to the District

as a public park for recreational use. The District has begun participating in the Navy's efforts to remediate the contaminated areas within the future regional park portion of the site. The effort to create the regional park will take years, but it is critical that the District is involved and has a seat at the table early in the planning process, as the Navy cleans up the regional park site and the City negotiates its economic conveyance of the adjacent lands. In April 2013, the Navy began preparing a disposal and reuse plan and Environmental Impact Statement (EIS). It is anticipated that the draft EIS will be released for public review this year or next. After the land is conveyed to the District, the District will need to prepare a Land Use Plan and associated California Environmental Quality Act documents.

Faria, Elworthy, and Podva developments in the southern Las Trampas area: Three development projects are dedicating or donating a total of 472 acres of land to the District in the southern area of Las Trampas Regional Wilderness. The Faria project was originally approved in 2006 and subject to a settlement agreement in 2008. A revised Faria project was approved in May 2014 by the Planning Commission, and that action has been appealed to the San Ramon City Council. The Faria project has a condition of approval to dedicate 144 acres to the District. The Elworthy project was approved in 2008 and has a condition of approval to dedicate 232 acres to the District. The Podva project was approved in 2014 and has a condition of approval to dedicate or donate 96 acres to the District. Each of these three development projects are at various stages of implementation of their land use approvals. The dedications of land to the District are anticipated to occur over the next several years.

Activity Measures:

- The Department participated in over 160 meetings with other agencies regarding District planning and land use interests.
- The Department submitted over 45 written communications regarding other agency projects that affect District planning and land use interests.
- The Department monitored agendas and actions of over 150 governmental agencies, typically about 45 per week, and tracked over 100 projects of other jurisdictions that involve District planning and land use interests.

Future Challenges:

- The development economy continues to improve and recover from the recent recession. There will most likely be an increase in both the number and magnitude of development projects seeking planning and land use entitlements, such as general plan amendments, re-zonings, subdivision maps, and conditional use permits. It will become increasingly challenging to monitor the planning and land use activities of the 150+governmental agencies, especially the 2 counties and 33 cities within the East Bay. The District will need to focus on being as efficient and effective as possible in providing leadership to help guide land use decisions of East Bay governments that relate to the District.
- 2) As the demographics of the East Bay continue to change, it will become increasingly important to address ethnic and cultural diversity in the District's planning and land use

efforts. As of 2013, Alameda County is one of the five most diverse counties in the nation, with 34% white/non-Latino, 26% Asian American, 23% Latino, 12% African American, and 5% other. The different land values and recreational preferences of different ethnic groups will need to be identified and considered.

Environmental Programs

Staff recently completed grant funding and permitting for the Breuner Marsh Restoration and Public Access Project at Point Pinole Regional Shoreline. A ground breaking ceremony was conducted in April 2014. Major earthwork is anticipated to commence in July 2014.

The EIR for Albany Beach Restoration and Public Access Project at McLaughlin Eastshore State Park was challenged by Sustainability, Parks, Recycling And Wildlife Legal Defense Fund (SPRAWLDEF) and Golden Gate Fields. Staff has been supporting legal counsel in defending against these challenges. Project implementation has been delayed accordingly; however, staff has secured \$2.2 million in grant funding, nearly completed design and obtained all permits to construct Phase I (neck) in 2015. Implementation of Phases II (beach area) and III (Bay Trail) is contingent upon obtaining possession of the Golden Gate Fields property necessary to construct the staging area and the San Francisco Bay Trail.

Staff has been developing a new conservation bank (bank) at Brushy Peak Regional Preserve and reactivating an existing bank at Pleasanton Ridge Regional Park. The goal of these efforts is to streamline and facilitate approval and mitigation for District capital and maintenance projects that affect special-status species habitats. Currently we are assisting the Planning and Stewardship departments in implementing capital improvements identified in the Pleasanton Ridge and Vargas Plateau Land Use Plans. Impacts from these two projects could be mitigated using the Brushy Peak and Pleasanton Ridge banks.

Activity Measures:

- Staff actively engaged in monitoring public projects, reviewing draft environmental impact reports and submitted comments on more than 42 projects in the past year.
- GIS staff produced more than 300 maps and exhibits for Board meetings, special Board sessions, acquisitions and capital development projects. In addition, staff provides GIS support to elected officials, public agencies and non-profit organizations upon request.

Future Challenges:

With continued recovery of the economy, development in the East Bay has begun to increase. Numerous previously approved projects (e.g. Dublin and Pittsburg) are now going to construction and new major projects are being proposed or approved (e.g. Richmond UC Campus, Pittsburg Southwest Hills Annexation, Pittsburg James Donlon Extension and Concord Naval Weapons Station). Staff will continue to closely review and comment on these projects to project and advocate for the District's interests.

Regional Trails Development

Through mid-2014, Trails Development staff has continued to advance the regional trail gap closure projects contained in the East Bay Green Transportation Initiative. The District has leveraged the TIGER II grant to advance nearly \$25 million in complex capital projects that are in the design or construction phases, with one project, the Alamo Canal Trail Undercrossing at I-580 completed and opened in October 2012. The Iron Horse Trail: Santa Rita Road to Dublin BART has been completed and is currently in the landscaping establishment/punch list period, and will open to the public this summer. The San Francisco Bay Trail: Martinez Intermodal to Crockett project is scheduled to be completed and opened this fall. The East Bay Greenway segment adjacent to the Coliseum BART Station is also scheduled for a late 2014 opening. Delivering the TIGER II projects is a team effort with other departments, including: Grants, Design and Construction, Operations, and outside agency partners that make significant contributions to the effort.

Trails Development staff also works with Planning and Stewardship to design interesting and sustainable trail networks for newly-acquired and existing parklands. Staff has assisted in the preparation of Land Use Plans for Sibley Volcanic Regional Preserve, Black Diamond Mines Regional Preserve and Clayton Ranch Regional Preserve. Trails Staff is also working with Planning on the design of the bicycle skills area included in the recently-adopted Land Use Plan for Oyster Bay Regional Shoreline.

Activity Measures:

- The Department facilitated over 4,000 hours of volunteer trail maintenance labor via the Ivan Dickson program.
- The Department completed three of the TIGER II-funded Green Transportation projects.
- The Department completed a road-to-trail conversion project at Pleasanton Ridge, and construct several new narrow multi-use natural surface trails within the District's parklands.

Future Challenges:

As the economy recovers and development activities move through the planning process and resume, the Trails Department must ensure that the District's trail-related interests are addressed.



East Bay

Conservation easement	A restriction that limits future property use to conservation or

Scenic easement	An easement for protection and/or development of
